According to the Guidelines for sale of electricity and power by conducting the Auction, Article 4, the right to participate in the auction has authorized representatives of the buyer who according to Article 4.3 should have:               <ul style="list-style-type: none"> <li>- authorization in written form, certified by a notary public in the Republic of Macedonia, or an authorization in the Macedonian language certified by a notary in the Republic of Macedonia,</li> <li>- where the authorization should contain the data for the authorized person (name and surname, number of passport or passport),</li> <li>- data on the person giving the authorization (name, surname, function and signature)</li> <li>- and the seal of the tenderer,</li> <li>- as well as containing a specific explanation for the given authorization (to represent the buyer for the particular advertisement and the right to increase the price).</li> </ul> </li> </ol> <p>Also in Article 5 of the Rules for Sale of Electricity and Power Surplus is provided if certain data submitted by the Economic Operator, indicated in the application, for the duration of the validity of the purchase agreement, the status or other changes, the Economic Operator informed AD ELEM immediately about the change and submitted new valid documents.</p> <p>For these reasons, if the buyer's manager appears at the auction, he / she should bring with him a personal identity document and the latest Current status not older than three days or Authorized.</p> <ol style="list-style-type: none"> <li>2.
