Appendix 1. Guidelines for the sale of electricity and power by conducting the Auction

In this Guidelines there is a change in Article 4 concerning the Authorization, so according to the new Guidelines, only the representatives have the right to participate in the auction, with one of the authorizations attached to the AD ELEM website **as Form No. 6**. Empty field indicating the period should be fulfilled with the period of validity of the authorization and signed by the responsible person of the Company (economic operator) according to 4.3.

This Authorization it is not required to be verify by notaries according the new Guidelines

Appendix 2. Guidelines for the sale of electricity by collecting the most favorable bid

In this Guide, the change relates to the manner of signing and submitting the Application - Form 3. Authorization (Form no.5) isn't necessary to be issued in case when the request is signed by the responsible person of the economic operator and it is sent from the official e-mail or a fax.

Under item 1 of the authorization: If the request (Form no.3) is signed by person other than responsible person within E.O., than E.O. must issue authorization appointing person for signing.

Under item 2 of the authorization: If the request (Form no.3) is sent by e-mail from another person (other than the manager or official e-mail of E.O.) than E.O. must issue authorization appointing person and e-mail address.

Empty field indicating the period should be fulfilled with the period of validity of the authorization and signed by the responsible person of the Company (economic operator) according to 4.3.
