The representative who will sign and submit the request by e-mail must be authorized by the responsible person in the company that participates in the procedure for selling electricity (Authorization - Form 5).

- If the request is submitted by fax, the authorization applies only to the person signing the request, under item 1 of the Authorization - Form 5.
- If the request is signed by the responsible person, no authorization is required.
- The authorization is submitted together with the Request by e-mail or fax.

Upon submission of the Request, the applicant confirms that he is familiar with all obligations arising from his signing.
